2020 was quite a year for everyone. Comstock Fire & Rescue recorded 1,908 incident responses for 2020 which was down 238 calls from the previous year. This was due largely in part to COVID-19. People were not wanting to go to the hospitals due to fear and there was much less vehicular traffic (which result in lower calls for Motor Vehicle Accidents) due to the stay-at-home orders. The department continues to partner with neighboring departments and community partners to provide a high level of service each day.

We strive to serve the residents of Comstock Township and our neighbors in Kalamazoo County with a combination of full time and part time personnel that staff our three fire stations, 24 hours a day, 7 days a week, year-round. Thanks to the continued support from our township board and residents, we were able to add 3 additional full-time firefighters to our system in 2020, totaling 12 full-time Firefighters staffing 2 per station 24/7. The department has a top-notch staff that works hard to provide the highest level of training, community risk reduction, fire prevention/public education and vehicle/equipment maintenance to ensure we can handle calls for service. We are truly a service-oriented department that is exploring ways to be a true community partner.

With the increase in full time staffing, training and community risk reduction efforts, we have continued an Insurance Services Office (ISO) rating for the township's fire protection service of 3. The lower the rating the better. The rating refers to how much the department meets the prescribed preparedness criteria. This will, hopefully, allow for lower insurance premiums throughout the township.

Due to the diversified call types, we see in and around our township, our personnel stay current by meeting or exceeding fire department related training for fire, hazardous materials, rescue and emergency medical services. The department was able to leap forward in the Capital Improvement Plan by receiving all new mobile and portable radios through a regional grant awarded from FEMA. This instantly modernized our communications ability on emergency scenes. The department continues to seek ways to keep training realistic by exploring opportunities in the township, at the regional training center on Nazareth Rd, throughout the state and beyond.

I want to thank the residents, business owners and the Comstock Township Board for their continued support to the fire department. The members of the Comstock Fire Department are residents as well, and we serve our neighbors with the highest level of training and care. We are exploring avenues of staying proactive with Community Risk Reduction opportunities.









Our Fire Department



Fire Station Information

Station 9-1

1960 River St Kalamazoo, MI 49048 (269) 345-2113

Built in 2009, Station 9-1 is the largest of the three stations. It was built in its current location, moving from the old station which was located near Merrill Park on Comstock Ave. The station features three large drive-thru apparatus bays. It is home to the pride of the fleet, a 1943 Seagrave fire engine. The station also contains the offices of the Deputy Fire Chief, Assistant Chief and Fleet Mechanics, as well as houses a large classroom which serves as the primary training location for firefighters. In addition to serving Comstock Township, this station covers all 9-1-1 requests for service in the Lakewood (Kalamazoo Township) area as well as provides mutual aid to Pavilion Township, the City of Portage, the City of Kalamazoo and the Kalamazoo/Battle Creek International Airport.

Station 9-2

Built in 2014, Station 9-2 is the newest of the three stations. The station features three drive-thru apparatus bays and two additional traditional bays. In addition to serving Comstock Township, this station provides mutual aid to Eastwood (Kalamazoo Township), the City of Kalamazoo, Cooper Township and Richland Township.

Fire Station Information

Station 9-3

8700 E Michigan Ave Galesburg, MI 49053 (269) 381-0804

Built in 2002, Station 9-3 is the oldest of the three stations. It was constructed in order to improve response times to Comstock residents and businesses located in the eastern portions of the township. It is also the smallest of the three stations, with only two drivethru apparatus bays. This station also serves as the administrative office for the Comstock Township Department of Fire & Rescue. It contains the offices of the Fire Chief, the Fire Marshal and the Administrative Assistant. In addition to serving Comstock Township, this station provides mutual aid to neighboring Galesburg/ Charleston Township and Augusta/Ross Township.



Total Responses for 2020: 299

Personnel:

The men and women of Comstock Fire & Rescue provide 24/7 essential fire suppression and investigation, education, rescue, and emergency medical services to over 15,000 residents and visitors, responding to nearly 2,300 requests for service on average each year. Our department consists of a full-time Fire Chief, Part-time Deputy Chief, Full-time Assistant Chief, Full-time Fire Marshal, Full-time Administrative Assistant, 12 Full-time firefighters, and 25 Part-time/Paid on Call firefighters.



COMSTOCK FIRE & RESCUE 2020 SIGNIFICANT ACCOMPLISHMENTS

- Conducted a Car Seat Checkup Event in February.
- Held our annual Fire Prevention Open House virtually on Facebook with a week-long series beginning October 5th.
- Participated in the 3rd annual countywide "Keep the Wreath Green" campaign.
- Over 300 Pre-Incident Surveys completed
- Over 50 Fire Safety Inspections completed.
- 20 home safety surveys were conducted.
- Installed 120 smoke alarms.
- Performed 10 car seat checks.
- 10 CPR and First Aid classes were held in the community.

January 4, 2020 - Comstock Fire & Rescue was dispatched around 9:44 p.m. Friday evening to a working structure fire on Cass St. near Higgins St. We arrived on scene 2 minutes later to find flames throughout the structure. The house appeared to be abandoned. Crews were unable to enter as the structure was starting to collapse soon after arrival. The fire was under control within an hour then extensive overhaul was conducted. Our Fire Marshal investigated the fire. No cause was determined. Kalamazoo Township Fire Department assisted on scene while Portage Department of Public Safety - Fire Division, Kalamazoo Dept. of Public Safety and Galesburg Fire Dept. back filled our stations.

January 6, 2020 - Congratulations to Probationary FF Will Cooper on his graduation from KVCC's Firefighter I & II Academy.



February 1, 2020 - Comstock Fire held a Car Seat Checkup Event at Station 9-1.

February 2, 2020 - Comstock Fire participated in the Parks and Recreation's Winter Warm up event held at Robert Morris Park. Events included s'more making, kids crafts, games and even a visit from some favorite Disney characters.





February 5, 2020 - Rescue/Brush Fire Unit 951 was placed in service at Station 9-1. This vehicle will primarily respond to EMS and Brush/Grass Fires in Station 9-1's district. (Pictured on the right). It is identical to our Rescue/Brush Fire Unit 953 (pictured on the left) that went in service Sept. 2018 at Station 9-3.

The new 951 is replacing the old Rescue 951 (2009 Chevrolet Tahoe) and Brush Truck 972 (1990 Dodge Pickup). Both vehicles will be used as utility vehicles and renamed 983 and 982.





March 27, 2020 - Around 4:00 pm today Comstock Fire & Rescue was dispatched to a canoer stuck in the mud in Morrow Lake approximately 100 yards from the shore. Comstock Fire was assisted by Cooper Fire Department's air boat to rescue the canoer. No injuries. Reminder to please stay safe and stay away from Morrow Lake while the dam is being repaired and the water levels are back up.







March 28, 2020 - Comstock Fire & Rescue participated in the "Birthday Drive By's along with our neighboring departments to help serve the children in our community. Times like these were difficult for everyone, but they can be especially difficult for children. It makes matters even worse when a child's birthday occurs during the Stay Home, Stay Safe orders. Comstock Fire & Rescue brought a fire engine out to homes and stopped outside with lights and sirens activated for a few moments so the children could see the truck from a distance.

April 14, 2020 - Congratulations to Captain Dale Beauchamp on his retirement.

Capt. Beauchamp (aka DB) had served on the department for over 30 years. Most of these years in a formal leadership role as a Lieutenant then Captain as well as acting Asst Chief. June 30, 2020 - Comstock Fire attended the large water flow operation training at Portage Fire along with other departments in the County.





June 30, 2020 - Search and Rescue training this week was held at the Kalamazoo Regional Fire Training Center (SIM City).







June 30, 2020 - Comstock Fire & Rescue was dispatched to a reported structure fire at Oak Terrace Apartments at 8:24 p.m. Arrived to find smoke conditions in a lower apartment unit, unknown if occupied at the time. Crews proceeded interior to locate a small fire in the kitchen and located an unresponsive occupant in the bedroom. The occupant was safely removed from the apartment and the fire was extinguished. The cause of the fire was unattended cooking. There were no working smoke alarms in the apartment unit or common hallway area. Quick action by fire crews helped save a life and minimize property loss. Comstock Fire worked with management to ensure working smoke alarms were installed.

REMINDER: Close bedroom doors when sleeping. Working smoke alarms save lives! Comstock Fire installs smoke alarms for free to Comstock Township residents

July 3, 2020 - A few of our personnel took advantage of this hot day and did some boat training on the Kalamazoo River.

July 27, 2020 - A crew from Comstock Station 9-1 assisted Pavilion Township Fire Department on scene of a structure fire on Piccadilly Drive. The fire was quickly extinguished and no injuries reported.

August 13,2020 - Rapid Intervention Team (RIT) and Mayday training this week at SIM City.







August 21, 2020 - Comstock Fire was dispatched just before 1:30 pm for a boater stuck on Morrow Pond near the Rosemont Boat Launch area. We were assisted by Cooper Fire Dept. with their air boat due to very shallow water. As a reminder, all watercraft please avoid Morrow Pond between S. 35th St and the Morrow Dam while repairs are being made on the Dam. Repairs are not expected to be completed until next year.



September 1, 2020 - Today we had new hire orientation at Station 9-1 where we swore in 6 new probationary firefighters. Welcome to the department.



September 21, 2020 - This morning before training we held a Badge Pinning ceremony at the Comstock Township Firefighter's Memorial for FF Will Cooper, FF Evan McGruder and FF Tim Hearld, who completed their 1-year probationary training. These 3 men put in a lot of hard work, dedication and many hours over the last year. Congratulations and keep up the great work!









September 28, 2020 - Comstock Fire was dispatched to a car and semi-truck accident on E. Michigan Ave and Morrow Street at 2:00 pm. Driver in car needed extrication from vehicle and reported serious injuries.



October 5, 2020 - It's Fire Prevention week! This year due to Covid-19 we unfortunately could not hold our annual "Open House", but we were able to share Fire Prevention tips on our social media pages each day. This year's Fire Prevention Week campaign, "Serve Up Fire Safety in the Kitchen™".

October 13, 2020 - Today we welcomed Probationary FF Ben Doorlag to the department. He is currently attending the Kalamazoo County MFR class and will be starting the Fire Academy in January.

Starting on Thanksgiving and running through midnight New Year's Day every time we responded to a structure fire, we replaced a green light with a red light. There is one white light that represents a fallen firefighter.





December 29, 2020 - Comstock Fire was dispatched early this morning to 725 Azuba for a well-involved structure fire. The home was believed to be vacant. Kalamazoo Township and Galesburg Fire Departments assisted on scene.





December 31, 2020 - Our Green Wreath ended the year with 9 red bulbs which represented each time we responded to a structure/cooking fire. "Keeping the Wreath Green" campaign is a great reminder to keep your home fire safe. With winter just getting started we want to remind everyone to be diligent with the things that can cause a house fire. Cooking fires, alternative heating sources, and unattended candles are some of the most common causes of a house fire. Working smoke alarms save lives.

Community Risk Reduction

Capt. Kevin Thompson & FM/Lt. Mike Kessler

Community Risk Reduction (often referred to as "CRR") is defined as a process to identify and prioritize local risks, followed by the strategic investment of resources to reduce their occurrence and impact. When properly applied, CRR coordinates emergency operations with prevention and mitigation efforts throughout both the community and at the fire station level. The fire service has a long standing tradition of being the first people that our residents call when they have an emergency. The idea of Community Risk Reduction is to go beyond that call and attempt to keep the emergency from ever happening, or to minimize the negative outcome of it. This in turn creates a much safer community for all residents and visitors.

The Comstock Fire Department has embraced this idea of prevention for many years. Our Fire Marshal has been very active in the schools and community with education on prevention of fires. The department has even responded to incidents where young children alerted other residents to a fire in the home and helped them exit the building safely. This is one example where the outcome could have been completely different if it was not for the education given during one of the fire prevention activities offered by the Fire Marshal.

Our department's motto is "Taking Care Of Those Who Depend On Us", and the implementation of a robust Community Risk Reduction plan helps to reinforce the idea that we are truly living up to our communities expectations. Through continued trainings on the topic of risk reduction and vigilance while in the community we hope to make our township as safe as possible. Some of the changes could be small, for example noticing a trip hazard in a hall-way of a home. But those changes could also be as large as a neighborhood wide drive to ensure every home has working smoke alarms. With both examples we are reducing the risk to both ourselves as firefighters, and to the residents of the township.

Fire Safety Inspections



The main goal of a Fire Safety Inspection is to promote and encourage a community safe from fire. A second goal is to improve community relationships between the fire department and the business community through professional, kind, and courteous interactions outside of a typical emergency situation.

Fire inspections help identify any potential problems of fire hazards. This way they can be corrected and people can be educated on how to identify them as well as how to respond. Sometimes property owners get lax about maintenance but regular fire inspections help ensure that the owners ensure that the building stays compliant.

In Comstock Township, over 150 Fire Safety Inspections were completed in 2020. Comstock businesses are very willing to have the inspection and correct any deficiency that they may have. The owners and managers understand that it is very important to make their business a safe place for the employees and customers that are in their buildings.

Fire Prevention Education in Schools



Comstock Fire is in its 20th year presenting the *Safe at Home* program in the Comstock Elementary Schools which includes 300 students. This program is a fire safety education curriculum developed by the State Fire Marshal's Office, in conjunction with the Michigan Public Fire Safety Education Committee. This program focuses on fire safety in the home – for everyone in the home.

Safe at Home addresses basic fire safety messages from pre-kindergarten through 4th grade. CFD conducted the classes at Comstock Elementary, and Comstock STEM Academy. The program is a 1/2 hour session held once a month throughout the entire school year. The curriculum includes "Fire Fighters are My Friends", "Reporting an Emergency 9-1-1", "What is Fire?", and other fire safety messages.

Station Tours



As part of the *Safe at Home* Program we normally have about 150 Comstock Kindergarteners come through our Station 9-1 and participate in activities such as a tour of the fire trucks, spraying water at a mock house fire, view a movie in the Fire Prevention trailer, escape from a simulated smoke filled house and proceed to call 911 after their escape and a few other activities with our EMS partners at PrideCare. However, due to COVID-19 we could not safely have them participate this year.

CPR Training



About 92 percent of sudden cardiac arrest victims die before reaching the hospital, but statistics prove that if more people knew CPR, more lives could be saved. Immediate CPR can double, or even triple, a victim's chance of serval. This program will teach participants critical skills and knowledge needed to perform CPR and use an-AED in the event of a sudden cardiac arrest and manage an emergency in the first few minutes until emergency medical services (EMS) take over. Comstock Fire has also added two more CPR instructors to our roster of 9 instructors to 11.

Fire Prevention Week - Open House



Our Fire Station Open House was held virtually this year on our Facebook page due to COVID-19. We normally have it at Station 9-1 and in the past has always been very successful and enjoyed by the community. We really missed seeing everyone in 2020. Although we couldn't get together in person we were able to provide tips and important information during Fire Prevention week (October 4th—10th) on fire safety and fire prevention via our Facebook page. We are very hopeful that we will be able to resume our annual open house in 2021.

Smoke Alarms Installed



The Comstock Fire Department continues to see many homes in which smoke alarms were removed or are not operating. All homes need working smoke alarms. The fire department recommends that one alarm be placed on each floor of your home and one in each bedroom and/or sleeping area. CFD believes smoke alarms are a key factor in preventing fire-related deaths.

Through our Smoke Alarm Program, Comstock Fire has installed 120 smoke alarms, and 20 carbon monoxide alarms in 20 homes, and each home receives a smoke alarm safety survey. This survey has shown that 89% of the homes in Comstock Township had an inadequate number of working smoke alarms, as a result 6 smoke alarms on average were installed per home. 100% of the homes did not have a carbon monoxide alarm, as a result each home received a carbon monoxide. Smoking is the leading know cause of residential fire fatalities in Michigan. 85% of the homes with a smoking had no working smoke alarms.

Install the smoke alarms also gave the fire department personal to educate the homes owners on the importance of a fire escape plan and sleeping with the bedroom door closed. We were also able to point out the fire hazards in the home and how to correct the problem.

Reflective Address Signs



With the help of the Comstock United Way Comstock fire personal has been able to purses the green address for home owners. By having address number on the home CFD will be able to respond to the needs of the residence quicker because of less confusion. When a home owner request an address sign CFD person will install it free of charge.

Car Seat Safety



Comstock fire now has 7 child passenger safety technicians who are car seat experts that have taken a 40-hour class with curriculum written by NHTSA in collaboration with National CPS Board and Safe Kids Worldwide. During the class they have learned the ins and outs of car seats, installation options, vehicle differences, harnessing procedures and more.

Motor vehicle crashes are the leading cause of death and injury for all children. Child restraints, or car seats, reduce the risk of injury by 71% to 82% and reduce the risk of death by 28% in comparison to children in **seat** belts alone.

Research has shown that using age- and size-appropriate child restraints (car seats, booster seats, and seat belts) is the best way to save lives and reduce injuries in a crash. ... Only 2 out of every 100 children live in states that require car seat or booster seat use for children age 8 and under.


The department has started to the car safety checks in August of 2019, the seat checks 0n done on the second Friday and forth Saturday of the month. Each technician spends about 45 minutes with the care giver teaching how to install the seat correctly.

In 2020 CFD has done a total of 10 seat checks and have given away 9 seats. This number is down from 2019 due to COVID-19




SMOKE ALARM SAFETY SURVEYS BY THE NUMBERS


